



## Plenti's Summer of Solar 2023 Promotion

### Terms and Conditions

The Terms and Conditions for Plenti's Summer of Solar 2023 Promotion (**'Promotion'**) are set out below. By participating in the Promotion, you are agreeing that you have read the Terms and Conditions in full and agree to be bound by them.

#### Promoter

1. The promoter is Plenti Pty Limited (**'Promoter'**), 5/14 Martin Place, Sydney, 2000.

#### Eligibility Criteria

2. Entry into the Promotion is limited to renewable energy vendor companies (**'Eligible Vendor Group'**) and their employees who are accredited with Plenti RE (**'Plenti'**) (accreditation to be determined by Plenti, in its sole discretion), in relation to Plenti's renewable energy loan and buy now, pay later products. For the avoidance of doubt, a broker will not be an Eligible Vendor Group (either on an individual or company basis) and is not eligible to participate in this Promotion.
3. Only loan applications that comply with Plenti's Introducer Agreement and associated guidelines will be accepted for the Promotion.
4. Only renewable energy loan and buy now, pay later products are included in the Promotion (**'Eligible Product'**). All other Plenti products, including, without limitation, automotive loan, personal loan and legal finance products are not included in the Promotion.

#### Promotion Dates

5. The Promotion commences at 12:01am AEST on 1 October 2023 and ends at 11:59pm AEDT on 12 January 2024 (the **'Promotion Period'**).

#### Selection of Winners

6. There are 9 prizes to be won. Prizes will be awarded to the Eligible Vendor Group and will not be awarded to individual employees.
7. Winning companies will be selected by the Promoter provided they meet at the Winner Selection Criteria for at least one (1) Category during the Promotion Period.

## Prize

9. Prizes are inclusive of GST.
10. The Prize is non-exchangeable, non-transferable, and is not redeemable for any other alternative item.
11. Should a Prize become unavailable, the Promoter reserves the right to substitute a Prize which it reasonably determines as being of equal value.
12. If there are multiple winners in a Category, the Prize will be split between the winners.

## Notification of Winners

13. Winners will be notified by the Promoter on or before the 31st of January 2023, first by telephone call and then in writing by email. It is the responsibility of the Eligible Vendor Group to ensure that their correct email is supplied.
14. If a winner either fails to claim their Prize within 7 days of the date the Promoter's contact and notification or the Promoter is unable to contact and notify the winner for 7 days after the end of the Promotion, the Prize will be deemed to be unclaimed.
15. In such circumstances, the Promoter may, in its sole discretion choose to provide the initial winner with the Prize (where it has been able to contact and notify the winner), or alternatively it may contact and notify an alternative winner (being an Eligible Vendor who satisfies the Prize's Eligible Product Winner Selection Criteria), in which case the processes in sections 13 and 14 above will apply.
16. The winner who has claimed the Prize agrees to the disclosure, without additional payment or permission, of their name, company name and state of residence and will co-operate with any other reasonable requests by the Promoter relating to any post-winning publicity.

## Plenti prize pack

17. The Plenti prize pack includes:
  - a. a Plenti merchandise pack (chosen at Plenti's discretion);
  - b. 1 x Plenti lead generation package (comprising inclusion in 1 x Plenti e-newsletter to geographically relevant database, plus the creation of 1 x promotional Plenti landing page);
  - c. 1 x 2-hour sales and marketing workshop conducted by Plenti;
  - d. 1 x presentation design (content brief to be provided by winner, presentation up to 25 slides);
  - e. 3 x blog posts (content brief to be provided by winning company, blog posts each of up to 600 words); and
  - f. 1 x 1 minute video edit (content brief to be provided by winning company, video to consist of stock video footage, winning company owned footage and original video interview footage filmed at Plenti's Sydney office).
18. Each winner of a Plenti prize pack:

    - i. contacting their Plenti Sales Team representative to arrange a kick-off meeting with Plenti to redeem the Plenti prize pack by 31 March 2024; and

  - b. may choose to redeem each element of the Plenti prize pack separately, but must do so by no later than 31 March 2024.

## Privacy

20. The Promoter may collect and disclose personal information in relation to this Promotion to third parties who assist it or are necessary for it to conduct the Promotion, including to issuers of any Prize (or part thereof). This may include your email address, telephone number and name.
21. The Promoter reserves the right to publish any participant's name and state in which they reside on its website and in email communications.

## General

These Terms and Conditions (and any contractual or non-contractual disputes arising out of or in connection with them) shall be governed by and construed in accordance with the laws of the state of New South Wales and any disputes relating or connected to these terms and conditions shall be subject to the exclusive jurisdiction of the courts of the state of New South Wales.
