



Transition Resource Corporation Head Start

Anderson, Elwood, Muncie, IN

Each project carried the standard TRC requirements for designing and building classrooms in newly acquired buildings to meet both state and TRC standards. The scope of work was a complete renovation of flooring, lighting, wall treatment, plumbing, mechanical and electrical as necessary. Over the last 5 years, we have done \$2.4MM worth of project renovation (design-build).










P3 Polytechnic Building (above)


Purdue Polytechnic (K-12+ University/ Industrial)

As partners with KRM Architects, we designed the facade through collaboration and 50K of the 94k sq ft industrial educational space for Anderson Community Schools, Purdue University, Purdue Polytechnic, City of Anderson, Anderson Innovation Center, and Flagship Enterprise. The \$14MM 94,000sf building will be used by students and



Liberty Christian School (High School) Anderson, IN

This is a 55,000 sq ft building renovation and build out. The proposed site will serve as the new campus for the school's growing high school. The project involved complete facade renovation, interior re-purposing, and design of new administrative offices, classrooms, cafeteria, science wing, art rooms, athletic director offices, and administrative space. The complete project budget is \$7.8MM.



9,000+ sq ft Community Health Center inside the former Anderson High School. The space included exam stations, nurses stations, administrative and managers offices.


MSD Washington Township
