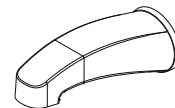
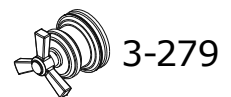
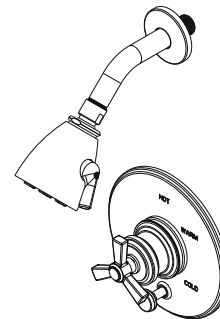

Tub and Shower Trim shall include showerhead with arm and flange, tub spout and faceplate with ADA compliant handle and diverter pull-knob. Showerhead shall have a maximum flow rate of 2.0 gallons (7.6 liters) per minute. Shower System Control Valve Trim(s) (Escutcheon/Handle) shall be ADA compliant when used with specified Shower System Control Valve. Tub and Shower Trim shall be Newport Brass Model 3-1602BP/\_\_\_\_ and single-control Tub and Shower rough valve shall be Newport Brass Model 1-595. Shower System Control Valve Trim (Escutcheon/Handle) shall be 3-279/\_\_\_\_ and Shower System Control Valve shall be 1-617.
