



FULL OFFICIAL RULES

MSR INDYCAR Ticket Giveaway (“Giveaway”)

NO PURCHASE NECESSARY TO ENTER OR WIN. LIMIT ONE ENTRY PER PERSON. LIMIT ONE PRIZE PER HOUSEHOLD.

1. **ELIGIBILITY.** Open to REMAX agents and broker/owners of the United States (excluding Puerto Rico, Guam and all other U.S. territories and possessions), who are eighteen (18) years of age or older at time of entry. You must be an individual to win. Groups, clubs, organizations, businesses and commercial and non-commercial entities cannot participate. You are not eligible to enter or win if you are an officer, director, employee, agent, or representative of RE/MAX, LLC (“REMAX”) (the “Sponsor”) or its affiliated and related companies (including without limitation, its parent, sister and subsidiary companies), retailers, advertising and promotional agencies, all other parties in any way involved in the development or administration of this Giveaway, including suppliers of materials or services related to the Giveaway, as well as their immediate family members (defined as parents, children, siblings and spouses including common law, regardless of where they live) and those with whom they are domiciled (whether or not related). Each post will count as an entry (an “Entry”).

Deadlines: All Entries must be received during the Giveaway Period. Entries submitted before or after the Giveaway Period will not be entered in the random draw. Proof of transmission is not proof of receipt of an Entry by Sponsor. The clock on Sponsor’s servers will determine the Giveaway Period.

Limit of one (1) Entry per person. Only one (1) Entry per person. Entrant may only use one (1) email address in connection with the Giveaway. Multiple entrants may not use the same email address.

3. **DISQUALIFIED ENTRIES/SENTRANTS.** Sponsor reserves the right, at its sole discretion, to disqualify any Entries or individual it finds, in its sole discretion, to be tampering with the entry process or the operation of the Giveaway. In the following circumstances Entries will be disqualified: lost, late, undelivered, invalid, unintelligible, incomplete, misdirected, illegible, or damaged Entries. In the following circumstances, entrants will be disqualified and all of their Entries will be judged void and disqualified: Entries generated by script, macro, robotic, programmed, or other automated means; Entries and/or entrants that do not comply with or satisfy any or all of the conditions set out in these Official Rules including failure to provide Sponsor with proof of identification; Entries submitted by unauthorized, prohibited or illicit means; Entries that contain false information; entrants who use more than one email address or identity to submit Entries; entrants who attempt to obtain or who submit more than the stated number of Entries permitted by the Official Rules; entrants tampering or attempting to tamper with the entry process or the operation of the

4. **DISPUTE REGARDING IDENTITY OF AN ENTRANT.** In the event of a dispute as to the identity of any person who submitted an online Entry, the authorized account holder of the email address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. The selected entrant may be required to show proof of being the authorized account holder.

The selected entrants will be notified by email or phone on May 05, 2026 at the email address or phone number provided with the entry. Please check your email and spam filters. Three (3) attempts will be made to contact the selected entrant.

6. **ODDS.** Odds of winning depend on the total number of Entries received within the Giveaway Period.
7. **ENTRANTS' AGREEMENT TO ABIDE BY RULES AND DECISIONS.** By submitting an Entry, entrants agree that they have read, understood and accepted these Official Rules and further agree to abide by them and all decisions of Sponsor, which shall be final and binding in all matters related to the Giveaway and the awarding of the Prizes.
