

## **Urgent: Food Recall**

Dear Sir or Madam,

This letter is to notify your company that Con Yeager Spice Company is performing a recall action for Trail Bologna Meat Processing kits because they may contain undeclared soy and wheat. The product recall involves the following product:

**Trail Bologna Meat Processing Kit, 17.88 Ounce pouches, UPC code 797442404137.  
Lot # B241851006, Best By 2-08-27**

**Pouches were distributed in boxes labeled Hickory Jerky Wild Game Processing Kit, Net 12.14 Oz, UPC code 797442404199. Lot # B241851006, Best by Date of 2-08-27. The lot and date can be found on the front center of the pouch, and in the top left corner of the box label.**

The recall was initiated after it was discovered by a customer that their box of Hickory Jerky Kits contained Trail Bologna Meat Processing Kits. Hickory Jerky kit contents were inadvertently packaged in Trail Bologna Meat Processing kit pouches. The Trail Bologna pouch does not declare soy, wheat allergens. The internal spice packet does, however, specify soy and wheat.

People who have an allergy or severe sensitivity to soy and wheat run the risk of serious or life-threatening allergic reaction if this product is consumed.

Con Yeager Spice Company requests that you review your inventory records and segregate and hold the products listed. If you have shipped any of this product, we request that you contact your customers and ask them to retrieve the product and return it to you. Once you have located all of the product received or distributed, place the product on hold. Complete the Recall Return Response Form and mail the completed response to Con Yeager at the address below.

Customers will be contacted by a company representative to make arrangements for a refund and for the return of the products. **Please do not destroy the product unless otherwise notified.**

We are undertaking this action in cooperation with the Food and Drug Administration (FDA). FDA officials may contact you to confirm that you have received this notice and are cooperating in this action.
