We hope your year is going well and that gathering your tax documents this season is going smoothly.

- Make sure to complete your organizers before submission
- Load your tax supporting documents with your organizer before sending
- Your portal session will time out. Please remember to save often so you do not lose entered data
- Do not email us documents with sensitive data. Use mail or best practice is to load to your portal
- Convert photos of documents into PDF format before sending

E-FILING/ Direct Deposit: All filing with the IRS and your states is done through the e-file process. We highly recommend choosing direct deposit for your refunds and it makes accessing the "where's my refund" status more immediate. If you need to update your Direct Deposit information, or to add Direct Deposit for the first time, please do so in the organizer on the page asking for Direct Deposit Info. You will need to provide your bank name, routing number, your account number, and type of account the deposit will go into (checking or savings).

EXTENSIONS:

We will not automatically file an extension unless you request us to do so in writing (email).

To file a federal or state extension, we will need the following:

- Name, address, and social security number(s)
- Total federal tax liability
- Federal income tax withheld
- Federal estimated tax paid

- Total state liability
- State income tax withheld
- State estimated tax paid
- Extension payments
 - » Payments can be made electronically either by paying online or having the balance due withdrawn from your account (we need your current banking information).
 - » Checks or money orders for Federal are made payable to the U.S. Treasury and state information may vary.

Once an extension is filed, you automatically have until October 15th to file your return. *Remember, an extension only extends the time to file, not the time to pay additional taxes owed, and it does not increase your chances of being audited.*

Payments made after April 15th are always subject to late payment penalties and interest even if a timely extension is filed. If you believe an extension is necessary, please confirm with us by April 1, 2025.

In Closing

Every year, we hope everyone receives a small refund. If so, you have made sure to keep as much money in your household over the year rather than waiting for the government to refund to you. Wishing you all a smooth and easy tax filing season!
