CLIENT ORGANIZERS: By mid-to-late January, we will have initiated your Client Organizer. **The first step for all clients is to sign your engagement letter!**

ELECTRONIC ORGANIZER: You will receive an e-mail with instructions to log onto our NEW website: www.cparh.com to access your secure portal.

PAPER ORGANIZERS: A few of you will receive paper organizers. We will send them via USPS. The questionnaire should be completed along with the other pages. If the organizer is returned blank, our fee will be increased to reflect the additional time required for us to complete it before beginning your tax preparation.

ONLINE PAYMENT OPTION: We offer the option to pay invoices via our website. Select "Pay Bill" on the home page of www.cparh.com. You can choose e-check and/or credit card options. There is no fee to use e-check; however, a nominal fee will apply to credit card payments and will be calculated on the screen. Enter the amount you would like to pay and in the reference box please enter your invoice number. You will receive an emailed copy of your payment. We are happy to offer this time saving option!

SUPPORTING DOCUMENTS:

Provide all pertinent backup documentation, W-2s, 1099s, interest statements etc., to initiate the tax preparation process. These documents can be sent to us either by paper copy or uploaded with your organizer. Please scan documents (not photos) for the best quality.

Please DO NOT email tax sensitive documents for your security.

When you have reviewed your organizer and uploaded your supporting documents, then "send to preparer". Once that step is completed, you may load additional documents via your "file exchange" if needed.

"First in, first out" is our philosophy when processing returns. We feel that this is the most equitable way to serve our clients.
