Now is the time for you to review any changes that may impact your 2022 tax year status and ensure you are aware of what those changes may consequently bring to your tax situation. ## Preparing for Tax Season

We begin preparing business tax returns in January and personal tax returns the first of February. It is important to ensure that we have your most up-to date information ahead of time including changes in email, phone or mailing addresses. Please review the enclosed insert listing the requested information for the upcoming tax season and an overview of our online (paperless) 1040 tax return services.

## Our Online Tax Return Services - Form 1040

Going paperless and using online tax return services (online Client Organizer, online delivery of tax returns, and e-filing), is the most efficient way to prepare your tax returns, and we encourage you to go paperless as the IRS and states are moving towards online processing. E-filing is now mandated by the IRS and most states and ALL returns that can be e-filed, will be e-filed.

All tax returns, paperless or otherwise, need to include your completed organizer, W-2s, 1099s (and other documentation listed in the Organizer) and those documents need to be delivered (preferably via your secure portal) to our office before we can begin to process your returns. This also gives us opportunity to ensure you are maximizing your tax benefits. Hainsworth CPA offers secure portals to transmit your sensitive information and we encourage you to utilize this option to ensure your documents are delivered safely and on time without envelopes, stamps or dropping off at our office. We also ask that you do not email us your tax documents as the portal is the most secure option. Once your return is completed, to e-file your return, we will need a signed authorization form(s) that gives us permission to e file your returns and we will get those to you for your signature at tax return review time.

#### In Closing

Tax regulations are always evolving, and we stay in compliance with these ongoing changes.
