**** How to qualify for Qualifying Charitable Organization (Including Foster Care)**

- 1) The donation must be a charity on the list from the AZDOR website and you must receive a receipt from the organization stating your donation qualifies for the specific credit. Donations do NOT qualify for both credits. They ARE independent of one and other.

We spark the greatness in Arizona's Foster Youth to help them realize their potential and to make the world a more peaceful and loving place.

WHAT WE DO

Since 2007, the Scott Foundation has touched the lives of more than 6,000 young people through experiential learning designed to encourage the value of selfless service. In giving back to others, these magnificent young adults redirected nearly \$764,000 in donations back to the community through their selfless service and compassion for others. Over time, we recognized that the youth who were most receptive to that concept were those who needed it most. So, we decided to redirect our efforts solely on the most vulnerable of Arizona's youth, Arizona's Foster Teen population.

TODAY'S PROGRAM

Scott Foundation disrupts the social norm to spark the potential greatness in AZ foster youth. We focus on 13-17 year olds and young adults 18-25, since they are considered to be within the Arizona Department Child Safety and Healthcare transition period. We assist these young people in gaining practical skills for life but more importantly, help them develop a healthier sense of self, compassionate hearts and purposeful career paths. They learn to live in selfless service to others and evolve emotionally so their perspective about themselves shifts and their individual potential can blossom. Our Master Class program averages 100 learning experiences per year, per person – many having experiences in 8 different and exciting careers. When they 'age out' of the system, at 18, they will have a chance at success and not become part of the statistics.

Colleen Walski, the founder of Scott Foundation, is a visionary and inspired leader who has woven together spiritual leaders, change-makers, community leaders, philanthropists, executives and entrepreneurs to enrich the lives of Arizona's Foster Youth. Inspired by the lasting memory of her only son, Scott, who was tragically taken when he was only 27, Colleen is dedicated to helping young people, just as Scott always did. Her passion for giving-back is the core principle that helped her overcome the pain from her loss and eventually heal. Foster youth also face pain and need healing from the traumatic lives they were experiencing before entering the system, which were often filled with physical, sexual and emotional abuse, neglect, poverty and crime. Scott Foundation helps these beautiful young people become whole so they can look forward to productive and satisfying futures.

Did you know?

Arizona Private School Tuition Tax Credit Law, A.R.S. Section 43-1089 allows individuals to redirect their state income tax to school tuition organizations that provide scholarships to private-school students in Arizona.

Here's how it works.

Donors control how their tax dollars are spent and children receive a quality, private education to the school of their choice. Thanks to the 2012 Overflow/PLUS (Private Learning Uplifting Students) tax credit, donors can claim an additional tax credit over-and-above the original tax credit.

- Individual taxpayers are allowed an annual credit up to \$1,183
- Married taxpayers filing separately can donate up to \$1,186 individually
- Married couples filing jointly are allowed an annual credit up to \$2,365
- Donors must first meet the \$593 (single) or \$1,186 (married) Original Tax Credit Program maximum in order to claim the Overflow/PLUS tax credit.

By simply participating, individuals will reduce the amount of tax money they owe to the State or increase the amount of their refund, dollar-for-dollar. Please note that this contribution may be eligible for a federal deduction. Consult your personal tax advisor on this matter.

Thank you for your support and believing that every parent deserves the right to choose the education that is best for their child.

Contribution Deadline: April 15th 2021. Pappas Kids Schoolhouse Foundation is a state of Arizona qualified Student Tuition Organization permitted to receive these tax credit contributions and award scholarships to economically disadvantaged students.

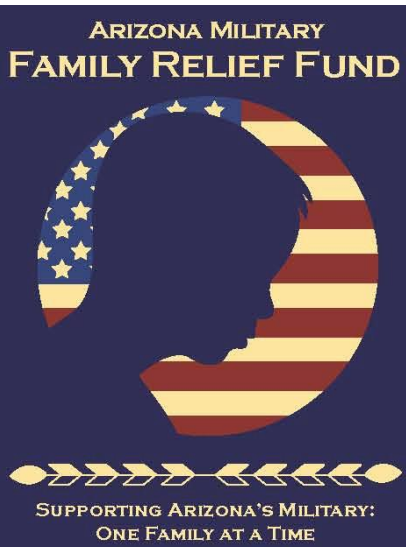

Arizona Military Family Relief Fund (MFRF) 2021 Contribution Form



What is the Arizona Military Family Relief Fund?

The Arizona Military Family Relief Fund (MFRF) was established by the Arizona Legislature in 2007 to provide financial assistance to the families of currently deployed service members and Post-9/11 Military and Veteran Families for hardships caused by the service member's deployment after September 11, 2001.

In 2018, Gov. Doug Ducey approved House Bill 2191, amending current statute 41-608.04 regarding the MFRF program. The amendment expanded the MFRF program to include applicants who deployed *before* September 11, 2001 (Pre-9/11) who meet the qualifying MFRF criteria.

How are MFRF assistance grants determined?

Financial assistance from the Arizona Military Family Relief Funds are determined by Advisory Committees, comprised of twelve members appointed by the Governor, as well as the ADVS Director or the Director's designee. The Pre-9/11 and Post-9/11 MFRF have separate advisory committees. In 2019, over \$1 million was granted, assisting over 200 Arizona veterans, service members and their families.
