** How to qualify for Qualifying Charitable Organization (Including Foster Care)

1) The donation must be a charity on the list from the AZDOR website and you must receive a receipt from the organization stating your donation qualifies for the specific credit. Donations do NOT qualify for both credits. They ARE independent of one and other.

Organization to create scholarships for kids in private school.



MISSION

We spark the greatness in Arizona's Foster Youth to help them realize their potential and to make the world a more peaceful and loving place.

WHAT WE DO

Since 2007, the Scott Foundation has touched the lives of more than 6,000 young people through experiential learning designed to encourage the value of selfless service. In giving back to others, these magnificent young adults redirected nearly \$764,000 in donations back to the community through their selfless service and compassion for others. Over time, we recognized that the youth who were most receptive to that concept were those who needed it most. So, we decided to redirect our efforts solely on the most vulnerable of Arizona's youth, Arizona's Foster Teen population.

TODAY'S PROGRAM

Scott Foundation disrupts the social norm to spark the potential greatness in AZ foster youth. We focus on 13-17 year old's and young adults18-25, since they are considered to be within the Arizona Department Child Safety and Healthcare transition period. We assist these young people in gaining practical skills for life but more importantly, help them develop a healthier sense of self, compassionate hearts and purposeful career paths. They learn to live in selfless service to others and evolve emotionally so their perspective about themselves shifts and their individual potential can blossom. Our Master Class program averages 100 learning experiences per year, per person – many having experiences in 8 different and exciting careers. When they 'age out' of the system, at 18, they will have a chance at success and not become part of the statistics.

How It Works:

REDIRECTING YOUR TAX DOLLARS FOR THE GOOD OF CHILDREN

The original tax credit law allows Arizona taxpayers to make a contribution to a School Tuition Organization, like PAPPAS KIDS, that will help fund private school student tuition.

You, the taxpayer, choose where to make the donation, not the government. This allows YOUR money to be used to give underprivileged students an opportunity to attend private schools in Arizona. When you contribute, you are making a donation. The state of Arizona will grant you a tax credit in return for that donation when you file your tax return.

IMPORTANT: If the taxpayer has actual Arizona state income tax less than the maximum donation amount allowable, the available credit in a given year is limited to the taxpayer's actual tax. The tax law allows a carry forward for up to five years if a donation is made in excess of the actual state income tax due.

Deadline: The deadline for private school tax credit donations is no longer December 31. Donations can be mailed or submitted online to PAPPAS KIDS prior to filing taxes, but no later than April 15 and still be eligible for the tax credit for the previous tax year.

If your donation is made between January 1 and April 15, you can determine which tax year to claim the credit. It must be postmarked or submitted online by midnight on April 15 - there are no extensions!

Receipts: An annual tax statement is sent by January 31 of the following year. Use forms 323 (Original tax credit) 348 (Overflow tax credit) and 301 (to summarize multiple tax credits) to claim the credit on your Arizona taxes.

Charitable Tax Credit

Tax Credit

With Arizona's Charitable Tax Credit (formerly known as the Working Poor Tax Credit), you can receive a dollar-for-dollar tax credit, up to \$841*, on your state income taxes while helping victims of domestic abuse – at no additional cost to you.

You can directly subtract your donation from the taxes you owe. It is a direct dollar-for-dollar credit back to you.

The charitable tax credit may be taken in addition to the public school tax credit and the private school tax credit.

Our Qualifying Charitable Organization Code is 20076.

How to Make a Contribution

Online: Make a donation here and select the Arizona Charitable Tax Credit button.

Gift must be postmarked no later than April 15, 2024. The credit can be applied to either the current or preceding taxable year, write "tax credit" in the memo line.

Arizona Military Family Relief Fund (MFRF) 2022 Contribution Form



What is the Arizona Military Family Relief Fund?

The Arizona Military Family Relief Fund (MFRF) was established by the Arizona Legislature in 2007 to provide financial assistance to the families of currently deployed service members and Post-9/11 Military and Veteran Families for hardships caused by the service member's deployment after September 11, 2001.

In 2018, Gov. Doug Ducey approved House Bill 2191, amending current statute 41-608.04 regarding the MFRF program. The amendment expanded the MFRF program to include applicants who deployed *before* September 11, 2001 (Pre-9/11) who meet the qualifying MFRF criteria.

How are MFRF assistance grants determined?

Financial assistance from the Arizona Military Family Relief Funds are determined by Advisory Committees, comprised of twelve members appointed by the Governor, as well as the ADVS Director or the Director's designee. The Pre-9/11 and Post-9/11 MFRF have separate advisory committees. In 2019, over \$1 million was granted, assisting over 200 Arizona veterans, service members and their families.
