Individual tax filers, regardless of income, can use <u>Free File</u> to electronically request an automatic tax-filing extension. You can also use this form to paper-file your extension.

- 1. Go to https://www.irs.gov/filing/free-file-do-your-federal-taxes-for-free
- 2. Click on blue "Use Free File Fillable Forms" button
- 3. Click on blue "Start Free File Fillable Forms" button
- 4. Click on blue "Start Free File Fillable Forms" button again
- 5. Create an account with an email address, user id, mobile phone number and password. ***It will ask you to verify the new account by either text or email.*
- 6. After filling in each field on the "Create An Account" page, click the blue "Create Account" button at the bottom of the page.
- 7. Once logged in, click on the light blue "File Extension" button at the top left of screen

- 9. If you owed the IRS in 2021, we recommend you make a similar payment with your extension and you would enter that amount on **line 4**. *Leave it as zero if you don't think you owe or do not want to make a payment with your extension.*
- 10. If you made and estimated payments for 2022, please add them up and enter that total for **line 5**.
- 11. Subtract the amount on line 5 from the amount on line 4 and enter that total on **line 6**.
- 12. If you are making a payment with your extension, enter the amount on line 7.
- 13. For **lines 8 & 9**, please check if either situation is applicable to you.
- 14. Click on STEP 2. E-file Your Extension Form



15. If you wish to file a paper Form 4868, print the Form 4868 that you just completed (include a check or money order of your payment if applicable) and then mail to the appropriate address in the instructions on next page.

Fill out the remaining sections on the "E-File Your Extension" page in order to electronically file your extension. Once you are finished with these sections, you can click the green "Continue to E-File" button shown below to finish.
