You may have been aware of these at the time, but do you know how they can affect you? Many Dentists, Orthodontists and other Dental Arts Professionals have a key staff member who handles much of the deposit of collections as well as much of the bill payment responsibilities. Others, utilize an external bookkeeper who either does the work off site or comes in a couple of times a month to do the recordkeeping. In most cases, this is a satisfactory arrangement, however, we have run across innumerable situations where there have been problems ranging from tremendous penalties incurred by late or non-payment of tax bills or other liabilities, to the extreme of bookkeepers helping themselves to client funds. We have been an expert witness in three situations where defalcations of funds were involved. Additionally, we have had innumerable engagements where the client thought the bookkeeper was filing payroll reports and paying the tax liabilities, only to discover they were way behind the eight-ball with large penalties and levies being implemented on their accounts.

All of our employees are bonded. Most have professional licenses to protect.
