

Tax Preparation & Filing

- Check your email-- we will email (or call) you questions, missing items & results
- Sign Docs-- When the return is complete, you will get an email that E-Signature documents are ready to sign
- Pay Bill-- Click Pay Bill on our site or in the Tax Portal to pay for tax preparation and complete the process

Once the return is prepared, signed & paid for we will e-file the return & you will get an acceptance email from IRS!

The Tax Portal will store your uploaded docs and copies of the completed tax return, for secure access 24/7 year-round!

If you would like prior year returns uploaded to the portal, simply ask your preparer.
