

RULES OF CONDUCT WITHIN THE VENUE



General

1. These rules of conduct within the Venue ("**Ground Rules**") apply in relation to the stay within the Venue and use of all facilities thereof.
2. These Ground Rules shall apply to all Ticket Holders/Package Holders (as the case may be) and, more generally, to all people who access the Venue and/or the facilities therein in order to attend to the Event (hereinafter jointly referred to as the "**Attendees**").
3. These Ground Rules, together with the "Terms of Use"/"Hospitality Terms of Use" (as the case may be), form an integral and essential part of the "Terms of Purchase"/"Hospitality Terms of Purchase" (as the case may be). Before entering into the Venue, these Ground Rules, the "Terms of Purchase"/"Hospitality Terms of Purchase" (as the case may be) and the "Terms of Use"/"Hospitality Terms of Use" (as the case may be) shall be expressly read and accepted by the relevant Purchaser – for him/her/itself and in the name and/or on behalf of any Ticket Holder/Package Holder (as the case may be) different from the Purchaser for whom the relevant Ticket/Package has been purchased and whose name appears on the relevant Ticket and/or Hospitality Pass (as the case may be) – through the dedicated button available on the Website. Failure to accept these Ground Rules, the "Terms of Purchase"/"Hospitality Terms of Purchase" (as the case may be) and the "Terms of Use"/"Hospitality Terms of Use" (as the case may be) will result in the relevant Ticket/Package being invalid. 4. Unless otherwise herein defined, capitalised terms shall bear the meaning ascribed to them in the Terms of Purchase/Hospitality Terms of Purchase (as the case may be).

Ground Rules

5. While within the Venue, all Attendees must comply with instructions and decisions given by any person authorised by RCCL, including RCCL's and Venue staff, contractors, officials, representatives, officers, volunteers, stewards or other security personnel, police officers and/or emergency and military services (each an "**Authorised Person**").
6. Attendees shall show their Tickets and/or Hospitality Passes upon request of any Authorised Person. Failure to show the Ticket and/or Hospitality Pass upon request of an Authorised Person may result in the relevant Attendee to be escorted outside the Venue without any resulting liability of RCCL towards such Attendee and/or the relevant Purchaser.
7. For safety reasons and for the orderly carrying out of the Event, it is strictly forbidden to bring the following prohibited items ("**Prohibited Items**") into the Venue and demarcated areas: (i) weapons of any kind, scissors, stones, knives, sound and/or music devices (musical instruments; megaphones; PA systems; or other similar items used for amplification or broadcast), systems for the emission of light beams (such as, *inter alia*, laser devices), bullets, hard freezer bags, long-handled umbrellas or other voluminous tools; (ii) marbles, cans, glass objects (such as, *inter alia*, glass bottles, glasses and cups) and any other frangible item which may cause damage to oneself or others; (iii) flammable and

pyrotechnic materials such as fireworks, rockets, flares, klaxons, dusts, aerosol generators and other devices for the production of smoke or visible gases; (iv) spray cans, corrosive and smearing substances as well as substances which may anyhow be harmful for the health and safety of the people present at the Venue; (v) alcoholic beverages, drugs, poisons or stimulating substances; (vi) advertising materials, save where expressly authorised in writing by RC23CL; (vii) propagandistic material containing racist, xenophobe, Nazi, sexist or political slogans; (viii) flag or banner long-poles, with the exception of synthetic flexible poles and the so-called “two-poles flags” with dimensions not exceeding a meter in length and a centimetre of diameter; (ix) stools or folding chairs; (x) ladders (including step ladders), boxes, crates, including folding crates and other similar items intended to achieve an elevated viewing position (xi) balls, frisbees and similar items; (xii) bicycles, scooters, skateboards, skates (including in-line skates) and any other form of transport (including without limitations hoverboards), except those required to be used as mobility aids by registered persons with mobility impairment; (xiii) non-accredited media equipment; (xiv) drones, kites, model aircraft or similar airborne/floating devices; (xv) any other object or item which may be deemed, at RCCL’s sole discretion, to be offensive, disruptive, dangerous or likely to infringe the rights and/or the health and safety of those participating in or attending the Event; (xvi) any dangerous item and/or substance not referred to above; and (xvii) any item and/or similar or equivalent to any of the above.

8. Prohibited Items will not be permitted within the Venue. Accordingly, the Authorised Persons may oblige the Attendee(s) bearing any Prohibited Item to leave it outside the Venue or surrender the same, should he/she wish to enter or remain within the Venue. In case of refusal, the Attendee shall be denied access to or, as the case may be, escorted outside the Venue without any resulting liability of RCCL towards such Attendee and/or the relevant Purchaser.
9. By entering the Venue, all persons are acknowledging that photographic images and/or video recordings (and/or stills taken from video recordings) may be taken of them and may also be used by RCCL (and any member of its group) for marketing and promotional purposes. Entry into the Venue is confirmation that all persons have agreed to such use of their image. If these images should feature an individual prominently, RCCL will make reasonable efforts to gain the agreement of that person before publishing such images, however, if this is not possible, entry into the Venue shall be deemed agreement unless RCCL is notified in writing to the contrary.
10. Further to paragraph 9, if such person is under 18 years of age, the parent, guardian or responsible adult who is accompanying them into the Venue shall be deemed to have provided agreement on their behalf.
11. Images taken with a camera, mobile phone or other electronic device cannot be used for any purpose other than for private and domestic purposes. You must not sell, license, publish (including, without limitation, via social media sites) or otherwise exploit photographs, whether for commercial gain or otherwise. RCCL shall own all intellectual property rights in materials taken or recorded in the Venue.
12. No person shall, whilst in the Venue: (a) use any electronic device to engage in any online betting activities in relation to the result, progress, conduct or any other aspect of the Event, including but not limited to the use of betting exchanges; (b) use any electronic device to relay information on the progress, conduct or any other aspect of the Event for betting activities, unlicensed commercial activities or any other purposes in contravention of these Conditions, unless authorised or permitted

to do so by RCCL; (c) offer to any third party any bribe or other reward to fix or to contrive in any way or otherwise improperly influence the result, progress, conduct or any other aspect of the Event; or (d) act in a manner that otherwise poses a threat to the integrity of golf.

13. RCCL operates CCTV cameras in and around the Venue which are monitored and recorded for the purposes of public safety and crime prevention. In accordance with Applicable Laws, RCCL may itself use, or provide information regarding persons to the authorities where it is necessary for the purposes of prevention or detection of crime and the capture or prosecution of offenders.
14. Save for guide dogs, no other pets and/or animals shall be permitted within the Venue.
15. No goods, (including literature), of any nature may be offered free or for sale by any persons within the Venue without the expressed prior written consent of RCCL.
16. While within the Venue, the Attendees shall comply with these Ground Rules, the "Terms of Use"/"Hospitality Terms of Use" (as the case may be) and all measures prescribed under the applicable laws and/or by the specific health and safety protocols (including those for Covid-19, if applicable) which may be implemented with regard to the Event.
17. Smoking of any kind, including the use of electronic (e) cigarettes, is strictly forbidden within the Venue except for the smoking areas which will be arranged therein.
18. Bringing alcoholic and/or other edible products (including without limitations beverages) into the Venue is strictly forbidden. RCCL reserves the right to confiscate any such products.
19. Mobile and/or smart phones will only be admitted within the Venue provided that they respect the maximum dimensions indicated in Exhibit 1 ("Permitted Device Dimensions") and that their owners comply with the following rules:
 - (a) all devices must be in SILENT mode at all times (no ring tone or other noises such as alarms, keypad tones, messages or battery or other notifications);
 - (b) calls must be made or received in approved designated areas only; and
 - (c) the rules on recording which are set out in the "Terms of Use"/"Hospitality Terms of Use" (as the case may be) are fully complied with at all times.
20. Other electronic devices (including without limitations computers, tablets and/or other communication devices or audio-visual equipment) may only be taken into and used within the Venue with the express approval of RCCL and provided that they do not inconvenience anyone participating in and/or attending the Event or anyhow disturb the game. Failure to comply with this paragraph 20 may result in the relevant Attendee to be escorted outside the Venue without any resulting liability of RCCL towards such Attendee and/or the relevant Purchaser.
21. The unauthorised sale or re-sale of Tickets/Hospitality Pass ("**Unauthorized Sale**") is strictly forbidden within the Venue as well as in nearby areas. Attendees who engage in such activities will be escorted outside the Venue and, where appropriate, reported to the police.

22. Attendees shall not engage in any form of “ambush marketing” (*i.e.* use of the publicity value of the Event without having any official involvement or connection with it) and shall not breach or infringe the rights of any partners, sponsors, suppliers, broadcasters or other RCCL’s or the Event’s commercial partners, nor conduct unauthorised promotions or other commercial activity within or in the proximity of the Venue.
23. The consumption of alcoholic beverages within the Venue is subject to all applicable licensing laws and only permitted in the bars or other authorised areas arranged within the Venue. RCCL reserves the right to close all or any such bars and/or other authorised areas at any time. Individuals that are 15 or under must be supervised by an adult at all times.
24. Attendees shall remain at all times outside the ropes which demarcate the playing fields of the golf course unless so expressly authorised and/or instructed by an Authorised Person.
25. Attendees shall not behave in any manner which RCCL deems, at its reasonable discretion, to be disruptive or endangering for the health and safety of other persons within the Venue, or which is deemed to be insulting or offensive to third parties or unreasonably obstruct the viewing of other spectators. Attendees shall not throw or discharge any missile or other item. Racist slogans or the use of foul or abusive language will not be tolerated. Failure to comply with the provisions of this paragraph 25 may result in the relevant Attendee to be escorted outside the Venue without any resulting liability of RCCL towards such Attendee and/or the relevant Purchaser.
26. The obstruction of gangways, access-ways, exits, entrances or staircases, congregating in non-designated areas or seeking entry to stands or seats for which the Attendee does not hold a valid Ticket/Hospitality Pass (as the case may be) or authorisation is strictly forbidden. The climbing of walls, trees, fences, stands or any other structure within the Venue (including either side of any perimeter fencing) is strictly forbidden.
27. Each Attendee is entitled to bring into the Venue one personal bag only, the size of which shall not exceed 40cm x 30cm x 30cm in size. Bringing into the Venue of bags exceeding the aforementioned size will only be permitted to allow the relevant Attendee to deposit them in the specific areas arranged for this purpose.
28. Defacing or obscuring any notice or advertisement present within the Venue is strictly forbidden.
29. Any kind of garbage is to be deposited in the designated containers and must not be thrown on the ground or otherwise left behind.
30. Attendees are strictly prohibited from placing or accepting bets on the Venue, either directly or through any third party, or from facilitating the placing of bets by others. Attendees are also strictly prohibited from collecting, disseminating, transmitting or publishing, by any means whatsoever, scores and statistical data relating to the Event for commercial or gambling purposes.
31. In the event of an evacuation warning, the Attendees must act in line with evacuation signals and instructions indicated in the relevant signs present within the Venue and/or given by the Authorised Persons, remaining calm and not cause panic.

32. Where applicable, these Ground Regulations also apply to the Venue airspace.

Legal

33. Failure to comply, in whole or in part, with these Ground Rules shall constitute a breach of the “Terms of Purchase”/“Hospitality Terms of Purchase” (as the case may be) and may result in the relevant Attendee to be escorted outside the Venue and/or demarcated areas.
34. Attendees shall indemnify and hold RCCL harmless of any damage suffered as a result of breaches of these Ground Rules.

Risk Factors

35. Attendees acknowledge the general risks associated with the game of golf and the attending of a major golf tournament, including risks associated with errant golf shots, the presence of large crowds in confined spaces and those other risks related to the attendance to sporting competitions in a golf course environment exposed to the natural elements. Consequently, RCCL shall not be liable towards the Attendees for damages arising out of the aforementioned risks.

Amendments

36. RCCL reserves the right to unilaterally amend, supplement or replace, in whole or in part, these Ground Rules for security, health, operational reasons or for reasons beyond RCCL’s reasonable control.
37. Where we have your contact details, we will notify you of any amendments to these Ground Rules. Amendments will be effective as from their publication on the Website on the “Ground Rules” section. Ticket Holders/Package Holders are therefore strongly encouraged to refer to the most recent version of these Ground Rules before entering into the Venue.
