# **UN Court Hears South Africa Genocide Case Against Israel**

### **Recap:**

The United Nations International Court of Justice (ICJ) is hearing a case brought by South Africa that accuses Israel of committing genocide against Palestinians in Gaza. The US called the lawsuit "counterproductive and completely without any basis in fact" [1].

### The Context:

- On October 7<sup>th</sup>, thousands of Hamas-led terrorists burst into Israel from Gaza, killing 1,200 people, ŵ and taking 240 hostages, of whom 132 remain in captivity. Israel subsequently declared war on Hamas to destroy the terrorist organization. 23,350 Gazans have died since the start of the war, 8,500 of whom are Hamas terrorists [2].
- The Genocide Convention, which was signed in 1948 following the Holocaust, describes genocide as ☆ "acts committed with intent to destroy, in whole, or in part, a national, ethnical, racial or religious group". The South African case is based on the extent of Gaza's devastation and quotes from Israeli officials that show intent to massacre Palestinians [3]. Israeli Prime Minister Benjamin Netanyahu responded, saying that "Israel has no intention of permanently occupying Gaza or displacing its civilian population [4]," and that Israel is fighting a war with Hamas, not the Palestinian people.
- Unlike the International Criminal Court, the ICJ does not have the authority to prosecute however, ź its opinions carry weight in international forums. The ICJ could quickly rule on South Africa's request for Israel to suspend its military campaign - but a final ruling on whether Israel is committing genocide could take years. Should Israel refuse to comply with ICJ orders, the case could be referred to the United Nations Security Council, which can impose punitive measures such as trade sanctions and an arms embargo [5].
