PLEASE TAKE NOTICE that on October 11, 2019, at 9:30 a.m.,¹ or as soon thereafter as counsel may be heard, in Department 302 of the San Francisco Superior Court, located at 400 McAllister Street, San Francisco, California 94102, Respondents DENNIS J. HERRERA, in his official capacity as City Attorney for the City and County of San Francisco and JOHN ARNTZ, in his official capacity as Director of the Department of Elections for the City and County of San Francisco and Real Parties in Interest BOARD OF SUPERVISORS and CITY AND COUNTY OF SAN FRANCISCO (collectively, with Respondents Herrera and Arntz, "Respondents"), will and hereby do demurrer to the Verified Petition for Writ of Mandate of Petitioner MICHAEL DENNY ("Petition"), pursuant to California Code of Civil Procedure § 430.10.

Respondents seek demurrer on the following grounds: the second through fifth causes of action in the Petition are time-barred under California Elections Code section 9295; the first cause of the action in the Petition fails to allege (and cannot so allege) that the requested relief would not substantially interference with the upcoming November 5, 2019 election, and alternatively the claim is neither ripe nor meritorious; the sixth cause of action fails to state a claim upon which relief can be granted because the City's inclusion of paid arguments in the voter information pamphlet and rules related thereto are authorized pursuant to its inherent powers as a Charter City and County and costs associated with printing paid arguments in the VIP do not qualify as campaign contributions under the Government Code.

Respondents' demurrer will be and is based on this Notice, the accompanying Demurrer, the accompanying Memorandum of Points and Authorities, the Request for Judicial Notice, the Declaration of Jenica Maldonado, the records and pleadings in the Court's file in this case, and upon such other and further matters as may be considered by the Court at the hearing on the demurrer.
