

TERMS AND CONDITIONS FOR “WESTFIELD CARINDALE SHOP FRESH AND WIN” PROMOTION

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Carindale Fresh Food Gift Card Giveaway” Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on QLD local time.

ELIGIBILITY

2. Subject to condition 3, this Promotion is only open to Australian residents aged 18 years or over. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions.
