

TERMS AND CONDITIONS FOR “WESTFIELD WHITFORD CITY HALLOWEEN COSTUME COMPETITION” 2016 PROMOTION

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Whitford City Halloween Costume Competition” Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on WA local time. Competition will commence from Monday 31/10/2016 and will end on Sunday 6/11/2016.

ELIGIBILITY

2. Subject to condition 3, this Promotion is only open to Australian residents aged 14 years or over. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.
3.
