

TERMS AND CONDITIONS FOR “WESTFIELD NATIONAL O-WEEK” PROMOTION 2017

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield National O-Week” Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on Australian Eastern Standard Time (AEST) or Australian Eastern Daylight Savings Time (AEDST) as the case requires.

ELIGIBILITY

2. Subject to condition 3, this Promotion is only open to Australian residents who have a valid/current student card and are aged 16 years or over.
