

TERMS AND CONDITIONS FOR “WESTFIELD CARINDALE SPEND AND WIN A KITCHENAID” PROMOTION

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Carindale Spend and Win a Kitchenaid” Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on QLD local time.

ELIGIBILITY

2. Subject to condition 3, this Promotion is only open to Australian residents aged 18 years or over. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. 6. Limit of one (1) entry permitted per eligible person per day.

DRAW DETAILS

7. The draw will take place at the Participating Centre, Centre Management, 1151 Creek Road, Carindale, QLD 4152 at the time and on the date indicated in Item 4. The Promoter reserves the right to draw reserves in case of an invalid entry or invalid entrant.

WINNER NOTIFICATION

8. The provisional winner(s) will be notified in writing. A provisional winner will only be deemed a winner once verified by the Promoter.

UNCLAIMED PRIZE DRAW

GENERAL

Nothing in these Terms and Conditions limit, exclude or modify or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the State and Territories of Australia (**"Non-Excludable Guarantees"**). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter and the Scentre Group of companies (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion.
