

# TERMS AND CONDITIONS FOR NUFFIELD STREET “NUFFIELD STREET FATHER’S DAY GIVE AWAY” PROMOTION

1. Information on how to enter and prizes forms part of these Terms and Conditions. Participation in this “Nuffield Street Father’s Day give away” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions.

## WHO CAN ENTER?

2. Subject to condition 3, this Promotion is only open to New Zealand residents aged 18 years or over.

3. The following are ineligible: (i) employees of the Promoter or any of the tenants or retailers in a Participating Centre (as defined in Clause 5 below) or any of the Promoter’s agencies or suppliers that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.
