

TERMS AND CONDITIONS FOR WESTFIELD “NUFFIELD STREET SPRING VIP DAY LINDEN LEAVES GIFT WITH PURCHASE” PROMOTION

1. Information on how to claim this gift with purchase forms part of these Terms and Conditions. Participation in this **“Nuffield Street VIP Day Ecoya Candle gift with purchase”** Promotion (**“Promotion”**) is deemed a acceptance of these Terms and Conditions.

PROMOTER DETAILS

2. Scentre (New Zealand) Limited (**“Promoter”**) is the promoter of this Promotion and its registered office is located at Level 2, Office Tower, 277 Broadway, Newmarket, Auckland.

WHO CAN PARTICIPATE
