

## TERMS AND CONDITIONS FOR “WESTFIELD BONDI JUNCTION BLANKET” PROMOTION 2018/2019

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Bondi Junction **The Elf on the Shelf 12 Days of Hide & Seek**” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on NSW local time.

### ELIGIBILITY

2. Subject to condition **4**, this Promotion is only open to Australian residents **aged 14 years or over**.
