

TERMS AND CONDITIONS FOR NEW ZEALAND WESTFIELD SHOPPING CENTRES “Nuffield Street’s be in to win* a copy of kikki.K’s Your Dream Life Starts Here and a \$20 Westfield gift card!” PROMOTION

WHO CAN ENTER?
