

## TERMS AND CONDITIONS FOR “WESTFIELD BURWOOD BLANKET” PROMOTION 2018/2019

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Burwood x Body Catalyst Valentine’s Day Giveaway” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on NSW local time.

### ELIGIBILITY

2. Subject to condition **4**, this Promotion is only open to Australian residents **aged 14 years or over**.
3. The following are ineligible: (i) employees of the Promoter, the Scentre Group or any of the tenants or retailers in Westfield Burwood Shopping Centre (“**Participating Centre**”) or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.
