

## **TERMS AND CONDITIONS FOR “WESTFIELD MT DRUITT BLANKET” PROMOTION 2018/2019**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this ‘Westfield Mt Druitt – The ultimate date night’ Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions. ### **ELIGIBILITY**
