

## **TERMS AND CONDITIONS FOR “WESTFIELD GARDEN CITY WIN A \$500 WESTFIELD GIFT CARD” 2019 PROMOTION**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Garden City Win a \$500 Westfield Gift Card” Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions. ### **ELIGIBILITY**
