

TERMS AND CONDITIONS FOR “WESTFIELD BURWOOD x SECRET LIFE OF PETS 2 FAMILY PASS & PRIZE PACK” PROMOTION 2019/2020

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Burwood x Secret Life of Pets Family Passes and prize packs” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on NSW local time.

ELIGIBILITY

3.
