

**TERMS AND CONDITIONS FOR “WESTFIELD INNALOO THE SECRET
LIFE OF PETS 2 WITH A CAT EAR GIVEAWAY SELFIE”
2019 PROMOTION**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Innaloo **“WESTFIELD INNALOO THE SECRET LIFE OF PETS 2 WITH A CAT EAR GIVEAWAY SELFIE”** Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions. ELIGIBILITY
