

**TERMS AND CONDITIONS FOR WESTFIELD  
WIN DAD THE ULTIMATE CRICKET EXPERIENCE WITH THANKS TO  
MASTERCARD PROMOTION - AUSTRALIA**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Win Dad the Ultimate Cricket Experience with Thanks to Mastercard Promotion” (**“Promotion”**) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in Australian Eastern Standard time.

**ELIGIBILITY**

2. Subject to condition 3, this Promotion is only open to Australian residents aged 18 years or over who hold a valid Mastercard.
3. The following are ineligible: (i) employees of the Promoter, the Scentre Group or any of the tenants or retailers in a Westfield Shopping Centre or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

**PROMOTION PERIOD**

4. This Promotion commences on 12/08/2019 and ends at 11.59pm AEST on 01/09/2019 (**“Promotion Period”**).

**HOW TO ENTER**

5. To be eligible to enter, individuals must purchase a ‘Red’, ‘Thank You’ or ‘Happy Birthday’ Westfield Gift Card of any value using a valid Mastercard from any Westfield Shopping Centre nationally, during the Promotion Period (**“Qualifying Purchase”**).
6. To enter, individuals must then visit [www.westfield.com.au/competitions/fathers-day](http://www.westfield.com.au/competitions/fathers-day) follow the prompts to the promotion entry page, input the requested details including their full name, contact telephone number, valid email address, their suburb of residence, and Qualifying Purchase receipt number and submit the fully completed online entry form during the Promotion Period. It is a condition of entering the Promotion that entrants agree for their personal information to be added to the Westfield Gift Cards database and to be used in accordance with the purposes set out in these Terms and Conditions.

**PROOF OF PURCHASE**

7. Entrants must retain a copy of their purchase receipt(s) for all entries as proof of purchase. Failure to produce the proof of purchase for all entries when requested may, in the absolute discretion of the Promoter, result in invalidation of ALL of an entrant’s entries and forfeiture of any right to a

prize. Purchase receipt(s) must clearly specify the Westfield Shopping Centre of purchase and that a Qualifying Purchase was made during the Promotion Period but prior to entry.

### **LIMITS ON ENTRY**

8. Multiple entries are permitted, subject to the following: (i) limit of one (1) entry per Qualifying Purchase; and (ii) each entry must be submitted separately and in accordance with the entry requirements.

### **DRAW DETAILS**

9. The draws will take place at Anisimoff Legal, Suite 5, Erina Plaza 210 Central Coast Highway, Erina NSW 2250 at 10:00am AEST on 06/09/2019 in the presence of an independent scrutineer. The Promoter reserves the right to draw additional reserve entries and record them in order in case an invalid entry or an invalid entrant is drawn.

### **WINNER NOTIFICATION**

10. The provisional winners will be notified in writing by email within two (2) business days of the draw. A provisional winner will only be deemed a winner once verified by the Promoter. Winners will have their name and postcode published at [www.westfieldgiftcards.com.au/online](http://www.westfieldgiftcards.com.au/online) commencing on 09/09/2019.

### **PRIZES**

11. The first three (3) valid entries drawn from all valid entries received will each win the major prize of an Ultimate Cricket Experience valued at up to \$12,880 depending on point of departure. Each prize is for four (4) people and includes:
  - I. Four (4) return economy airfares from winner's nearest capital city to Melbourne, Victoria (if required). For clarity, flights will only be provided if the winner resides outside of VIC). If a winner is from VIC, then the prize does not include airfares and the airfare component of the prize is not redeemable for cash;
  - II. Two (2) nights twin share minimum 5-star accommodation (in either a family room or two twin share rooms) in Melbourne, VIC. Exact accommodation to be determined by the Promoter in its absolute discretion;
  - III. Four (4) passes to the Mastercard Suite, on the opening day of the Domain Boxing Day Test (Thursday 26 December, 2019) at the Melbourne Cricket Ground;
  - IV. Four (4) passes to The Boundary Social Pod on Day 2 and 3 (being Friday 27<sup>th</sup> and Saturday 28<sup>th</sup> December, 2019) of the Domain Test Series at the Melbourne Cricket Ground.
12. Spending money, meals, taxes (excluding airline and airport taxes), insurance, transport to and from departure point, additional transfers, items

of a personal nature, in-room charges and all other ancillary costs are not included. Winners and their companion/s must depart from and return to the same departure point and travel together. Frequent flyer points will not form part of the prize. Winners may be required to present their credit card at time of accommodation check in. Prize must be taken to coincide with the above-mentioned matches and is subject to booking and flight availability. During the entire duration of the prize, a nominated parent/guardian must accompany any person under 18 years of age.

Entrants also agree to comply, and ensure that each subsequent ticket holder complies, with Cricket Australia's 2019/20 Ticket and Entry Conditions (available at [www.cricket.com.au/tickets](http://www.cricket.com.au/tickets)) supplemented by any conditions of entry imposed by the venue operator. The Promoter will provide every person attending a match as part of the promotion with a copy of Cricket Australia's 2019/20 Ticket and Entry Conditions with delivery of the prize tickets.

15. Further to the above, the cricket match ticket prizes are subject to the event venue and ticket terms and conditions, including any applicable age restriction. The Promoter and event organisers hereby expressly reserve the right to eject any winner (and/or his/her companion/s) for any inappropriate behaviour, including but not limited to intoxication, whilst participating in any element of the prize.

## **UNCLAIMED PRIZE DRAW**

16. Any runner up prize that has been won but remains unclaimed will be entered into an unclaimed prize draw. The unclaimed prize draw for any unclaimed runner up prize/s will take place at the same time and place as the original draw on 01/10/2019, subject to any directions from a regulatory authority. Winners (if any) will be notified in writing by email within two (2) business days of the unclaimed prize draw and their name(s) will be published on [www.westfieldgiftcards.com.au/online](http://www.westfieldgiftcards.com.au/online) commencing on 04/10/2019.
17. Any major prize that has been won but remains unclaimed will be entered into an unclaimed prize draw. The unclaimed prize draw for any unclaimed major prize will take place at the same time and place as the original draw on 06/12/2019, subject to any directions from a regulatory authority. Winners (if any) will be notified in writing by email within two (2) business days of the unclaimed prize draw and their name(s) will be published on <http://www.westfieldgiftcards.com.au/online> commencing on 09/12/2019.

## **GENERAL**

18. Incomplete, indecipherable or illegible entries will be deemed invalid.
19. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.

Nothing in these Terms and Conditions limit, exclude or modify or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the State and Territories of Australia ("**Non-Excludable Guarantees**"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter, the Scentre Group of companies and Cricket Australia (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter, the Scentre Group of companies and Cricket Australia (including their respective officers, employees and agents) are not responsible for and exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or correspondence that is late, lost, altered, damaged or misdirected (whether received by the Promoter or not) due to any reason beyond the reasonable control of the Promoter; (d) any variation in the prize value to that stated in these Terms and Conditions; (e) if any of the abovementioned cricket matches are cancelled, delayed or postponed for any reason beyond the control of the Promoter; (f) any tax liability incurred by an entrant or winner; or (g) taking of a prize.

30. Cricket Australia reserves the right in its absolute discretion to change or amend the Domain Boxing Day Test or Gillette T20 INTL fixtures without notice. Neither the Promoter nor Cricket Australia accept responsibility for the cancellation or delay of any cricket match connected with this Promotion for any reason beyond the control of the Promoter or Cricket Australia.
31. As a condition of accepting a prize, a winner (and their companion/s) must sign any legal documentation as and in the form required by the Promoter and/or prize suppliers in their absolute discretion, including but not limited to a legal release and indemnity form.

## **PRIVACY**

32.
