

## TERMS AND CONDITIONS FOR “WESTFIELD WHITFORD CITY ELF ON THE SHELF HUNT 2019” PROMOTION

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Whitford City Elf on the Shelf Hunt Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on WA local time.

### ELIGIBILITY

2. Subject to condition 3, this Promotion is only open to Australian residents.
3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions.
