

TERMS AND CONDITIONS FOR “WESTFIELD GARDEN CITY INSTA-MAS” 2019 PROMOTION

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Garden City “INSTA-MAS” Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on QLD local time.

ELIGIBILITY

2. Subject to condition **4**, this Promotion is only open to Australian residents **aged 18 years or over**.
3.
