

## TERMS AND CONDITIONS FOR “WESTFIELD GEELONG THE ELF ON THE SHELF 12 DAYS OF HIDE AND SEEK” PROMOTION 2019

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Innaloo **The Elf on the Shelf 12 Days of Hide & Seek**” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions. ### ELIGIBILITY

2. Subject to condition 4, this Promotion is only open to Australian residents **aged 14 years or over**.
