

TERMS AND CONDITIONS FOR “WESTFIELD TEA TREE PLAZA X REBEL SCHOOL HOLIDAY ” 2020 PROMOTION

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Tea Tree X **REBEL SCHOOL HOLIDAY**” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on SA local time.

ELIGIBILITY

2. Subject to condition **4**, this Promotion is only open to Australian residents **aged 14 years or over**.
3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions.
