

## TERMS AND CONDITIONS FOR “WESTFIELD WARRINGAH MALL BLANKET” PROMOTION 2020/2021

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Warringah Mall **“Summer Starter Pack”** Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on NSW local time.

### ELIGIBILITY
