

TERMS AND CONDITIONS FOR “WESTFIELD HELENSVALE’S SHARE THE LOVE PHOTO MOMENT PROMOTION”

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Helensvale **SHARE THE LOVE** Photo Moment Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on QLD local time.

ELIGIBILITY

2. Subject to condition **3**, this Promotion is only open to Australian residents **aged 14 years or over**.
3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.
4. The following are ineligible: (i) employees of the Promoter, the Scentre Group or any of the tenants or retailers in Westfield Helensvale Shopping Centre (**“Participating Centre”**) or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

 2. Upload the photo to Instagram, hashtag #westfieldhelensvale and tag @westfieldhelensvale and have their account set to public.
 3. They must be following Westfield Helensvale to be eligible.

LIMITS ON ENTRY

7. Multiple entries permitted per person, however each entry must be **substantially unique** and submitted separately and in accordance with entry requirements.

DRAW DETAILS

9. The provisional winner(s) will be notified in writing via Instagram. A provisional winner will only be deemed a winner once verified by the Promoter.

GENERAL
