

miniBOUNCE 'Win a Party' Competition

TERMS AND CONDITIONS

1. Information on how to enter and prizes form part of these Terms and Conditions. ELIGIBILITY

DRAW DETAILS

WINNER NOTIFICATION

8. The winner will be notified by email on 10 January 2022.

PRIZES

MAJOR PRIZE

The winner drawn at random will win a miniBOUNCE party valued at \$500.

Conditions of Major Prize:
