TERMS AND CONDITIONS FOR "MR. CONSISTENT GIFT WITH PURCHASE" 2022 PROMOTION

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this "Mr. Consistent Gift with Purchase Promotion ("**Promotion**") is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on WA local time.

ELIGIBILITY

- 2. Subject to condition **3**, this Promotion is only open to Australian residents **aged 18 years or over.**
- 3. - 6. An **"Excluded Retailer"** means any of the following retailers: Coles and Woolworths. An **"Ineligible Transaction"** means any transaction recorded on an invalid receipt, as specified in Clause 7 below.
