

**TERMS AND CONDITIONS FOR “COMPLETE A WAITANGI DAY
QUESTIONNAIRE TO GO IN THE RUNNING TO WIN A COOMERA KIDS
MINI PASS” PROMOTION**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Westfield Coomera **“Complete a Waitangi Day Questionnaire to go in the running to win a Mini Coomera Kids Pass”** Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on QLD local time.

ELIGIBILITY

2. Subject to condition 3, this Promotion is only open to Australian residents aged 15 years or over. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.

The following are ineligible: (i) employees of the Promoter, the Scentre Group or any of the tenants or retailers in Westfield Coomera Shopping Centre (**“Participating Centre”**) or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

WINNER NOTIFICATION

8. The provisional winner(s) will be notified via phone. A provisional winner will only be deemed a winner once verified by the Promoter.

UNCLAIMED PRIZE DRAW

GENERAL
