Greater Boston Convention and Visitors Bureau Dine Out Boston – Restaurant Week Boston OFFICIAL RULES

MUST BE 18 YEARS OF AGE OR OLDER TO PARTICIPATE AS A SUBMISSION. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

SPONSOR/ADMINISTRATOR: Dine Out Boston is sponsored and administered by the Greater Boston Convention and Visitors Bureau ("Greater Boston CVB", "GBCVB", and "Dine Out Boston"), Two Copley Place, Suite 105, Boston, MA 02116 (the "Sponsor").

ELIGIBILITY: Dine Out Boston (the "Program") is open only to legal U.S. residents who are 18 years of age or older as of August 6, 2017. Void where taxed, restricted or otherwise prohibited by law. Employees, officers and directors of the Sponsor, the Administrator, their respective immediate families (parent, child, sibling or spouse) and/or household members and any other persons or entities associated with the Program are ineligible to enter or win.

TIMING: Dine Out Boston will be defined by the following time periods:

1. The Submission Period ("Submission Period") – Entries will be accepted between 11:00 a.m. Eastern Time ("ET") on August 6, 2017 through 10:59 a.m. ET August 11, 2017 and 11:00 a.m. ET on August 13, 2017 through 10:59 a.m. ET August 18, 2017.

2. The Voting Period ("Judging Period") – Will take place at the start of the Submission Period on August 6, 2017 for each Prize Period through August 18, 2017.

3. Prize Period ("Awarded Period") – Each day between August 6, 2017 to August 11, 2017 and August 13, 2017 to August 18, 2017 a new contest will begin at 11:00 a.m. ET and will end at 10:59 a.m. ET the following day.

Please note: submissions received during the Prize Period will be considered based on the number of votes received during that timeframe; any voting that takes place on entries received before the new contest Awarded Period are appreciated but will not be accounted for in the WINNER DETERMINATION/NOTIFICATION – please see section for further details.

Please note: an Entrant may enter unlimited photos of their Dine Out Boston experience throughout the submission period, but only the top entry will be considered for a prize during its awarded period. Each entry stands alone for votes; votes will not be combined with other entries' votes. Limit one prize per Entrant.

Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision. In the event of a dispute as to the identity of a winner based on an email address, Facebook, Twitter, or Instagram account, the winning Entry will be declared to be the authorized account holder of the email address associated registered to the Facebook, Twitter or Instagram account in question submitted at time of Entry.
