Local Lodging Tax Up for Renewal this November

The Laramie County lodging tax will be up for renewal on the November election ballot. The local lodging tax is not a new tax; it has been in place since 1987 when it was first approved by Laramie County voters. It has been renewed by the voters every time it has been on the ballot since then. The lodging tax is paid by visitors staying in local hotels, campgrounds, and bed-and-breakfasts. The proceeds of the lodging tax are used by Visit Cheyenne to promote and develop the county's hospitality industry.
