# **2016 BIKETOBERFEST® MASTER PLAN**

## **MAIN STREET**

1. 140 Main Street - Stevens Tire & Auto: 9,700 square feet of outside retail sales of accessories, motorcycle parts, maintenance, repairs, trailers, RVs LED lights, pin stripping, clothing, souvenirs, jewelry, photos, autograph signing, food and non-alcoholic beverages, and portable stereo system with amplified sound, displays of static vehicles. Display banners or signs. Paid parking. Charity activities include alcoholic and non-alcoholic beverage sales by Veterans Support Fund and drawing by donation to benefit Serenity House/Haven Recovery/Boy Scouts.
2. 205 & 216 Main Street – Beachside Auto Parts: 3,600 square feet of outside retail sales of motorcycle parts, clothing, helmets, led lighting, bike trailers, paid motorcycle parking at this location and at 9, 11, 17, & 25 Peninsula Drive. Display banners or signs.
3. 300 - 310 Main Street - Boot Hill Saloon 400 square feet of outside sales of food, alcoholic and non-alcoholic beverages, Boot Hill logo wearing apparel miscellaneous souvenirs. Outside entertainments with amplified sound by live band, jukebox, DJ, video projections, contests, promos. Religious distribution of bibles by Calvary Christian. Display banners or signs.
4. 316 Main Street - Main Street Station: 1000 square feet of outside retail sales, sale of food, alcoholic and non-alcoholic beverages, paid motorcycle parking and live outside entertainment with amplified sound. Display banners or signs.
5. 405 Main Street - Tombstone Silverworks: 1,080 square feet of outside retail sales of t-shirts, clothing, leather, boots, fairings, radio, polish, sunglasses, jewelry, footwear, patches, novelties, radios, static displays, sale of food and non-alcoholic beverages.
6. 500 Main Street - Humphreys & Son: Suite 100, 110 & 120 - 2,195 square feet of outside retail sales of, leather goods, eyewear, T-shirts, patches, pins, trinkets. Paid motorcycle parking. Display of banners or signs.
7. 504 Main Street - Biker Clothing Company/Biker Design: 1,816 square feet of outside retail sales of event merchandise ladies fashion tops and lemonade cart. Paid parking. Display of banners or signs.
- 7a. 505 Main Street – Biker Clothing Company/Biker Design: 1,816 square feet of outside retail event merchandise, ladies sales of event merchandise, ladies fashion tops and lemonade cart. Paid parking. Display of banners or signs.
8. 511 Main Street - Main Street Ocean Club Laundry - 990 square feet of outside retail sales of t-shirts, sweatshirts, hats, event merchandise. Display of banners or signs.
9. 604 Main Street -Beach Photo and Video: 2,400 square feet of outside retail sales. Display of banners or signs.
10. 700 Main Street -Full Moon Saloon: 844 square feet of outside retail sales of alcoholic and non-alcoholic beverages, food, tobacco, Full Moon Saloon logo merchandise, apparel and accessories. Recorded and live entertainment with amplified sound, DJ contests and promotions. Paid motorcycle parking. Display of banners or signs.

11. 701-705 Main Street - Dirty Harry's Pub, Bank & Blues Club: 1,476 square feet of outside retail sales of food, non-alcoholic and alcoholic beverages, apparel, accessories, tobacco, live entertainment, DJ with amplified sound, contests and promotions. Display of banners or signs.

12. 777 Main Street - Biker Clothing Company/Biker Design: 4,800 square feet of retail sales of event merchandise, ladies fashion, food and non-alcoholic beverages. Alcoholic beverages to be sold by charity TBD. Paid motorcycle parking. Display of banners or signs.

13. 800 Main Street - Froggy's Saloon: 1,900 square feet of outside retail sales of alcoholic and non-alcoholic beverages, food, Froggy's souvenirs, DJ with amplified music and dancers. Display of banners or signs.

14. 801-811 Main Street - Good Sports/Hot Leathers: 1,600 square feet of retail sales, leather products, t-shirts, and other merchandise that is regularly sold inside. Display of banners or signs.

## **FAIRVIEW AVENUE**

15. 118 E. Fairview - BMW Motorcycles of Daytona: 3000 square feet of outside retail sales of motorcycles, motorcycle parts, accessories, apparel and food and non-alcoholic beverages. Display of banners or signs.
