

APPLICATION DEADLINE Postmarked by May 4, 2018

Dear Marketplace Vendor Applicant:

The Grapevine Convention & Visitors Bureau invites you to apply to participate in the 32nd Annual GrapeFest® – A Texas Wine Experience to be held September 13, 14, 15 and 16, 2018.

Please follow all application instructions carefully and note that the deadline for submitting the application for GrapeFest is **May 4, 2018**. Applications postmarked by May 4, 2018 will be considered on time. Due to the volume of applicants and limited space, we are unable to accept late applications – **the deadline date is firm.**

All applicants will be notified by letter of acceptance or non-acceptance by mail and email by June 22, 2018. Checks and photos (if applicable) are returned to applicants not selected.

The following items must be completed and enclosed for the application to be considered:

- (1) Completed Application;
- (2) Notarized Hold Harmless Agreement;
- (3) Payment (the payment will only be deposited if you are accepted);
- (4) Current 4x6 photos of your products and your overall display. Maximum of six photos and
- (5) Copy of Texas Sales Tax and Use Permit (photocopies are acceptable).

Cancel prior to June 25, 2018 – 100% refund Cancel prior to July 25, 2018 – 50% refund Cancel on or after July 25, 2018 – **No refund**

GrapeFest is an outdoor event and there are no refunds for inclement weather.
