Notes & Highlights

Due in part to lower convention attendance related to show schedules plus one fewer weekend day vs. last July, visitation saw a -3.4% decrease over July 2017.

Room inventory reached 147,587 (up +0.4%) while citywide occupancy came in at 90.8% (-3.7 pts) and RevPAR was \$108.12, down -8.1%.

Convention attendance came in at approx. 408,000, down -19.5%, as some tradeshows rotated out of Las Vegas this year (Association of Woodworking and Furnishings Suppliers, 18,500 attendees; IDEA Health & Fitness Association, 10,000 attendees), and others were scheduled in different months vs. last July (World Pet Association held in June this year, 20,000 attendees; Black Hat/TechWeb held in August this year, 17,400 attendees.)
