- A valid and working website (Social networking sites are not valid –Twitter/Facebook).
 Web-site must list your Las Vegas' office contact information.
- A copy of your Clark County Business License or City Business License.
- State of Nevada Business License is not accepted; City business license must fall within Clark County.
- · Business' Clark County address and phone number.
- Full contact information on the attached application.
