What To Know About How to Access and Enjoy

The Central Coast is one of the most breathtaking destinations in California. While the destination experienced a winter that severely affected parts of the region, visitors are still able to access some of the best that Big Sur has to offer. Multiple closures along Highway 1 through the Big Sur region of the Central Coast are affecting travel between San Luis Obispo County (SLO CAL) and Monterey County. The great news is many of the iconic attractions along this stretch of *The Original Road Trip* are still accessible and open for business including:

Big Sur North is open and travelers can visit the 26 miles of Highway 1 coastline from the Monterey Peninsula all the way down to the Big Sur Ranger Station. Highway 1 in San Luis Obispo County

Over 80 miles of Highway 1 is open in San Luis Obispo County with access to all destinations including Morro Bay, Cayucos, Cambria, San Simeon (Hearst Castle) and Ragged Point. Travelers coming from Monterey County are encouraged to access Highway 1 via Highway 101 south, heading west through wine country on Highway 45, just south of Paso Robles.

Detour Along Highway 101

Detouring along *The Original Road Trip* doesn't mean missing out on bucket list experiences. Closure Locations & Area Map

- The closure at Pfeiffer Canyon Bridge in Monterey County (1 mile south of Big Sur)
 will remain in place until the bridge is rebuilt, which is expected in the fall of 2017
- A long-term closure at Mud Creek Slide (about 19 miles north of the San Luis Obispo County-Monterey County line). Caltrans has not yet released an expected date to reopen this section of Highway 1
- A short-term closure also remains just north of Ragged Point in San Luis Obispo County as a smaller slide is being removed
