The project consists of a total of three (3) base bid schedules, to construct the improvements associated with the runway signage and marking re-designation at the general aviation airports operated by the Palm Beach County Department of Airports. The project includes new airfield signage, repaneling of existing airfield signage, relocation of existing signage, demolition of decommissioned signage, new runway and taxiway pavement marking, pavement marking removal, and asphalt pavement surface sealing. Base Bid Schedule 1 includes the work at Palm Beach County Glades Airport (PHK). Base Bid Schedule 2 includes the work at Palm Beach County Park Airport (LNA). Base Bid Schedule 3 includes the work at North Palm Beach County General Aviation Airport (F45).

The work must conform to plans and specifications, which may be obtained or examined on or after **Monday, April 24, 2017**. The Department of Airports is not responsible for the content of bid documents obtained by means other than indicated below:

The plans can be printed at full size (22" by 34"). The Contractor should access the site on a daily basis to be aware of any new data that is added to the site. The potential bidder shall not, for any reason, provide the access data to any other person or entity.

Bid proposals must be submitted on the forms provided by Palm Beach County and accompanied by a bid security in the form of a certified check, cashier's check, money order or a bid bond submitted on the form provided, in favor of Palm Beach County in the amount of not less than five percent (5%) of the bid price.

All bids must be submitted in a sealed envelope as described in the INSTRUCTIONS TO BIDDERS.
