

## Visit Phoenix "2018 SummerScapes Sweepstakes"

### Official Rules

NO PURCHASE OR REQUESTS FOR INFORMATION OR MARKETING MESSAGES ARE NECESSARY TO ENTER OR WIN, AND WILL NOT INCREASE YOUR CHANCES OF WINNING. YOU HAVE NOT WON YET. VOID WHERE PROHIBITED.

**Who May Enter:** You must be 18 years or older, and a resident of one of the United States or the District of Columbia to enter the Sweepstakes or win a prize, and you must have computer access, an e-mail address and Internet access as of the date of entry. Employees, officers, and directors of Visit Phoenix, *The Arizona Republic*, the promotion prize sponsors, or of their respective affiliated companies, distributors, dealers, retailers, accounting or legal firms, printers and advertising and promotion agencies, and the immediate family members and individuals living in the same household of such persons, are not eligible to participate in this Sweepstakes or win a prize. For purposes of these Official Rules, "immediate family members" mean spouse, children, parents, parents of spouse, siblings, and spouse's siblings. **Ineligible Entries:** The use of automated entry devices is prohibited; all such entries are void. Only completed entries will be eligible for a chance to win the prize. Visit Phoenix will not verify receipt of entries, and proof of submission will not be deemed proof of receipt by the Sponsor (or as proof of entry).
