## **CVB Staff Update**

James Meacham reported to the committee that the CVB is in the process of restructuring staff to better support the mission of the CVB and to adapt to the changes from the recent departures of Allyson Teague and Melissa Murguz in addition to the loss of the full time interns next week.

Meacham reported that the CVB's intern Taylor has accepted a job in Virginia and will begin her career in marketing and Mary Scott Norris will return to Catawba for her senior year, but will remain on part time at the CVB.

Meacham also reported that Lauren Litaker is now the Director of Marketing and Tara Ludwig will assume the role of Director of Public Relations and Communications. Additionally the CVB

is in the process of trying to fill the position of Tourism Services Coordinator and hopes to have it filled in September or October.

## **Marketing Funds Requests**

James Meacham presented two funding requests to the committee for consideration.
