Edward Norvell called the meeting to order at 6:09 PM.

Grassroots Grant Program

Anne Scott Clement stated \$29,991 was allotted by the North Carolina Arts Council for this year's Grassroots Grant Program. The eligibility amounts depend on the tier the organization falls under. Tier One organizations are 501c3 where their primary business is arts. This tier qualifies for any amount requested. Tier Two organizations are non-profit groups that include an art component. This grant only covers artistic support. Tier Three organizations are governmental groups whose primary focus are not art related and not covered in general operating budget but has an art component. This grant can include funds not only for artistic support, but for the program itself. Each organization was scored based on the grant report and criteria required for grant application. Some notations were made as critiques for the applicants so they could be better prepared in the future. Clement directed the Board's attention to copies of the grant applications for closer review.

The recommendation from the Grassroots Grant panel is to offer the Concert Choir \$1,000, Lee Street Theatre \$5500, Piedmont Players \$5500, Blues and Jazz \$6,000, Rowan Helping Ministries \$1750, Rowan Parks and Recreation \$1,000, Sculpture Show \$8250, and Human Relations Council \$1,000. The SRCVB staff will send out the Grassroots Award letters.

Financials

Cindy Morgan, Treasurer, presented the financials for the group. From the county, \$24,692 was received and \$12,187.50 was received from the city. Morgan directed the Board's attention to the total income, disbursements, and administrative expenses. Norvell expressed that one good thing is the allocations for the coming year have increased a bit.
